**CALL TO ORDER**

Supervisor Marshall made the motion to approve the minutes of the Ways and Means Committee on March 20, 2019. Supervisor Green seconded the motion. Motion carried.

**FLCC**

FLCC Financial Statements for Year  
Ending August 31, 2018

J.R. Dempsey, Vice President for Administration and Finance, introduced Craig Stevens of The Bonadio Group who gave a brief presentation and highlighted the Executive Summary of FLCC audit results for the year ending August 31, 2018.

**PUBLIC SAFETY**

- ▶ **Transfer:** *Sheriff ~ Project Lifesaver*

Supervisor Green made the motion to approve the budget transfer of \$6,422.80 from Appropriated Fund Balance for the Project Lifesaver Program. The funds were not previously removed from year 2018 and transferred into year 2019. Supervisor Singer seconded the motion. Motion carried.

- ▶ **Resolution:** *District Attorney ~ Reclassifying an Office Specialist I Position to a Senior Clerk Position*  
Supervisor Green made the motion to approve the resolution to authorize the reclassification of Office Specialist I to Senior Clerk, effective upon adoption. Supervisor Marshall seconded the motion. Motion carried.
- ▶ **Resolution:** *Public Defender ~ Salary Adjustment - Matthew Mix*  
Supervisor Marshall made the motion to approve the resolution to adjust the salary of Matthew Mix, Assistant Public Defender, at Band 5, Step I (\$97,282), effective upon adoption. Supervisor Green seconded the motion. Motion carried.

- ▶ **Resolution:** *Adopting Local Law No. 2 (Intro.) 2019 After Public Hearing and Notice of Adoption of Local Law*  
Supervisor Singer made the motion to approve the resolution that Local Law No. 2. (Intro) of 2019, allowing the creation of a position of Deputy Director of Real Property Tax Service, be adopted. Supervisor Marshall seconded the motion. Motion carried.

Motion carried to approve the resolution to amend the agreement awarding ARC NY, Inc., Ontario County Chapter, an additional amount of \$393, making the total amount of the 2019 agreement not to exceed \$343,103.

Supervisor Gallahan made the motion to approve the resolution for the Agreement with the Friends of CMAC and FLCC in regard to the design, construction, maintenance, and operation of the said improvements on file with the Clerk of the Board. Supervisor Ingalsbe seconded the motion. Motion carried.

- ▶ **Resolution:** *FLCC ~ Establish Capital Project No. 01-2019 as the FLCC/CMAC Evacuation and Fencing Project*  
Supervisor Marshall made the motion to approve the resolution to establish Capital Project No. 01-2019 as the FLCC/CMAC Emergency Evacuation and Fencing Project; and further, that the budget for CP 01-2019 be established as stipulated in the resolution. Supervisor Ingalsbe seconded the motion. Motion carried.
  
- ▶ **Resolution:** *Public Works ~ CP 07-2013, Jail Modifications - Authorizing Contract with SWBR Architects for Professional Consultant and Design Services for the Ontario County Jail Roof Repair*  
Supervisor Singer made the motion to approve the resolution authorizing a contract with SWBR to provide said project services for a cost not to exceed \$15,000; and further to amend the budget for the project as stipulated in the resolution. Motion carried to approve the resolution to create Capital Project No. 02-2019, Chiller Replacements; to authorize the fund transfer and establish the budget for said project as stipulated in the resolution; and that a contract with C&S Companies be approved for final design services, construction administration services, and post construction phase services for a cost not to exceed \$63,459. The term of the contract will commence on April 19, 2019, and expire on November 29, 2019.
  
- ▶ **Resolution:** *Public Works ~ CP 02-2019, Chiller Replacements: Award of Contract for 20 Ontario Street Roof Replacement Design and Construction Administration Services to SWBR Architects, Engineers and Landscape Architecture*  
Motion carried to approve the resolution to approve a contract with SWBR Architects, Engineers and Landscape Architecture for final design services, construction administration services, and post-construction phase services for a cost not to exceed \$6,000; and further, to authorize the fund transfer and amendments to the project budget as stipulated in the resolution.
